

ASSISTANT/ASSOCIATE PROFESSOR DEPARTMENT OF PHYSICAL THERAPY

(12-month, Tenure Track) January 22, 2025

Samford University's School of Health Professions seeks a collaborative faculty member interested in serving in a Christian university environment to apply for the position of assistant/associate professor in the Department of Physical Therapy. This tenure-track faculty position is a 12-month appointment and will begin in Summer/Fall 2025.

Qualified candidates will be a graduate of a CAPTE-accredited physical therapy program, have a minimum of 5 years of experience as a practicing physical therapist, and be eligible for Alabama licensure as a physical therapist. In addition, candidates must hold a clinical doctorate (DPT) or academic doctoral degree (PhD, DSc, EdD, or similar). To be considered at the rank of Associate Professor, the candidate must demonstrate a strong record of high-quality publications in peer-reviewed journals, and evidence of excellence in teaching and mentoring graduate students. Preference will be given to candidates with a board-certified clinical specialty in Orthopedics/Sports/Cardiopulmonary physical therapy. Additional requirements include:

- Eligibility for licensure as a Physical Therapist in Alabama
- A commitment to academic excellence
- Ability to work effectively with faculty, students and colleagues
- Willingness to engage in community outreach activities, including serving in our pro-bono physical therapy clinic
- Willingness to support the Christian mission of Samford University and the College of Health Sciences
- Willingness to travel for university-related purposes, as needed

The successful candidate for this position will have responsibility of teaching in the Doctor of Physical Therapy program, service and scholarship. Academic rank and salary are dependent upon qualifications, clinical experiences, previous academic teaching experiences, program management experience and scholarship accomplishments.
